The Memorandum is supplemented and amended as follows:

All references to the “Maximum Offering Amount” are hereby amended and restated to reflect that the Company is offering Notes in a maximum offering amount of \$20,000,000.

All references regarding the minimum investment required for an investment in the Notes are hereby amended and restated to reflect that the minimum investment for each Note is \$50,000.

For further clarity, the “Summary of the Offering” is hereby amended to amend and restate the following sections:

The Offering	The Company is offering unsecured promissory notes in a maximum offering amount of \$20,000,000 (the “ Maximum Offering Amount ”).
Minimum Investment	Each Note - \$50,000 or such other amount determined by the Manager at its sole discretion. All minimum investment amounts are subject to the Manager’s right to change or waive the minimum amount at the Manager’s sole discretion. The entire amount of a subscription for Notes must be paid upon investment and no further capital calls or capital contributions will be required or requested.
